* Water: System is still not removing Manganese as good as it should. An Email to the Pureflow system is forthcoming. The system started In 2017, not sure when it was started. John Kiernan will be asked. The chlorine level was increased to see if it would help the filters, but it did not. The problem could be the make up of the water. We need to find a plan to make them work. We were told to do an acid wash and we need to find someone to come do it. We need guidance on that.

A Tap for Monitoring also needs to be addressed. Wastewater meters also need to be fine tuned and upgraded.

Jeff says there is a grant for the valve turning Aug 2 and 3rd. Mary will need to run an ad to say we will be flushing at night.

John Kiernan is coming Monday 7/24/23 to check the meters and airline going to Woodsville and other items. Jeff is going to ask if there is a meter, we can install on Woodsville side to see if they monitor the same #s we get.

* Manhole repairs and water shutoffs Jeff is looking to see if there are seals to plug holes in Manhole covers. There are approx. 5 locations where there are shut offs that need to be dug up and repaired. Jeff talked to J&S and he would come do the work. There is no idea of what this would cost we will try to find out.

Chip said we are going to lean on Jeff for his expertise. Mike wanted to know if the homeowners needed notification the majority would not be affected by the water being shut off. Jeff thought we should try to start working on some of them.
