**Highway – Salting of Sidewalks – Roads are a priority for bus routes. More diligence was being asked in attention to the sidewalks. The next stop will be to try and do the magnetic meter to see if we can read it correctly if that determines to prove excess flow, we will need to do a more permanent solution.
